My name is Pablo R. Guerrero M. and I am a Nicaraguan citizen. I'm also an attorney and notary public by profession, having studied law and social studies. I graduated from UNAN-LEON; the second-oldest university and law school in Central America. I have been a defender and promoter of human rights, founder and co-founder of civil rights movements, which led to my having to go into exile starting in 2018 until I arrived at this grand and beautiful nation, the United States. Almost 5 years have gone by since I left my country, my family, my friends and others who are dear to me.

I am the father of two sons. Isidro Emilio Guerrero Salgado, 20 years old, former student of dentistry. I wasn't able to attend his graduation from high school for the reasons mentioned above. My other son is Pablo Felipe Guerrero Salgado, 18 years old, in his final year of pre-university studies. I wasn't able to attend the graduation ceremonies of either son because of my situation as defender of human rights and my membership in civil rights movements in Nicaragua. There have been physical and psychological effects on his education; he was denied entry into the Public University that I had graduated from simply because he was my son. Not only that, but two years ago, he suffered a knife attack resulting in a wound that required stitches. This attack was carried out by two pro-government people. They were prevented from fully carrying out this attack by other citizens who helped my son. As far as my younger son is concerned, I had to move him from the school he had attended since he was little; I had to exile him to another city in his own country, living practically in seclusion. They have only been able to attend their school activities, the supermarket and stay in the apartment. Both of them had to go to Honduras, the country next door, to get their COVID vaccines and he was not allowed to get the vaccine because he didn't have a party membership card.

It has been difficult and hard these past five years to be separated from them. They always tell me that they need my affection and protection.

Once I was divorced from their mother, custody, guardianship and parental rights were granted to me. I have always watched over them 24 hours a day in accordance with my legal responsibilities as well as my responsibilities as father. It would be a dream come true if I could be reunited with them and, even better, live with them. It truly has been difficult for them since I've been separated from them when they were 15 and 13 years old respectively, they have had to take care of themselves at home. Not only that, but their mother has another son who is 8 that she is responsible for. She also works in the city that they are from and hasn't been able to live with them because of safety concerns and fear. Not only that, but she has two sisters who are supportive of the government that is causing the crisis in my country.

I would be eternally grateful for this help because this radical change has been difficult for my personal and professional life. If I were able to be together with them again, it would contribute to the personal and humanitarian development of two people I have a moral commitment to educate.

Soy Pablo R. Guerrero M. de nacionalidad nicaragüense, Abogado y Notario Público de profesion, con estudios en ciencias Jurídicas y Sociales, Graduado de la UNAN-LEON, de la segunda universidad y facultad de derecho más antigua de Centro América, he sido defensor y promotor de derechos humanos, fundador y cofundador de movimientos civiles, cuya consecuencia obligo a exiliarme en tres países desde el 2018 hasta llegar a esta gran y bella nación de los Estados Unidos, han pasado casi 5 años desde que deje mi tierra, mi familia, amistades, entre otras que son parte de mi vida afectiva.

Soy padre de dos hijos Isidro Emilio Guerrero Salgado de 20 años, ex - estudiante de la carrera de Odontología, de quien no pude estar en su graduación de secundaria por motivos antes expuestos, también soy padre de Pablo Felipe Guerrero Salgado, de 18 años, estudiante del último año de bachillerato, ambos a consecuencia de mi situación de promotor y defensor de derechos humanos y perteneciente a movimientos civiles de Nicaragua, han tenido consecuencias físicas y psicológicas en cuanto a su formación, a Isidro Emilio me le fue negado el

ingreso a la Universidad Publica de donde yo me gradué, simplemente por ser mi hijo, sin omitir que hace 2 años fue agredido físicamente con un cuchillo provocando una herida que requirió puntos, provocada por dos sujetos a fines al gobierno, quienes fueron frustradas sus intenciones por personas civiles que auxiliaron a mi hijo. En cuanto a mi hijo menor tuve que cambiarlo de escuela donde había estudiado desde pequeño, teniendo que exiliarlo dentro de su mismo país a otra ciudad, viviendo prácticamente un cautiverio, limitados asistir solo a sus actividades escolares, supermercado y apartamento, ambos tuvieron que ir al país vecino de Honduras para poder vacunarse contra el COVID, pues le fue negada por no tener carné de afiliación partidaria.

Ha sido difícil y duro estos 5 años de estar separados de ellos, siempre me manifiestan que necesitan de mi calor y protección, pues al divorciarme de su señora madre la custodia, guarda y patria potestad me fue otorgada, siempre he estado las 24 horas pendientes de ellos con mis obligaciones de ley y principalmente con las de padre. Seria mas que un sueño el poder reencontrarme con ellos y aun mas vivir con ellos, pues ha sido difícil para ellos, al separarme cuando tenían 15 y 13 años respectivamente tener que auto asistirse ambos en el hogar, sin omitir manifestar que su señora madre tiene otro hijo de 8 años a quien cuida y su vida laboral esta en la ciudad de origen de ellos, quien no ha podido convivir con ellos por razones de seguridad y temor, pues tiene 2 hermanas que son a fines al gobierno causante de la crisis de mi país.

Estaré eternamente agradecido por este apoyo, pues ha sido difícil este cambio radical en cuanto a mi vida afectiva y profesional, mi acercamiento y reencuentro con ellos contribuirá en la formación personal y humanitaria de dos personas de quienes tengo el compromiso moral de formarles.
